Hello! My name is Ann Richmond, and I am the Membership Co-Chair and a member of the Moen Lake Chain Association Board. As Co-Chair of the Membership Committee, I am reaching out to Moen property owners to renew or join the Moen Lakes Chain Association (MLCA).

Did you know that the MLCA is a non-governmental organization which:

- Monitors the public landing on Moen Lake for invasive species transmission into the Moen Chain water bodies that might occur from boat launchings (Clean Boats, Clean Waters program)
- Annually places, maintains and removes the channel markers on the Chain
- Communicates of matters of general interest surrounding physical conditions on the Chain to MLCA members

As a volunteer, non-profit organization, all of these activities are funded by member dues and contributions as well as grant funding for activities from the Wisconsin Department of Natural Resources. Our focus is the health and well-being of the Chain many of us call home or use for recreation.

We hope you will renew or join the MLCA for 2023 to help us take care of the Chain. We keep our dues amount low – only \$25 – to encourage participation in the MLCA. **We also offer a Sponsor a Day at the Landing** membership option. For \$100, you cover the cost of manning the Moen Lake boat landing as part of our Clean Boats, Clean Waters initiative, and it also includes your annual dues. We offer this option as a result of feedback from property owners that wanted to assist with CBCW, but weren't able to man the landing. Thanks to all of those who joined us a Boat Sponsor last year!

NEW THIS YEAR: On the form, you will also see an “opt-in” option for a property owner directory. Those of you that opt in will have your name, lake property address, alternate address and phone number listed in the directory. The directory will be emailed to anyone that choose to participate. Don't forget to include your email on the form!

Thanks in advance for your support of the MLCA and its goal for a high quality of life on the Moen Lake Chain!


